Praised for transformative leadership, Kelly Kennedy Garcia serves as the Director of the Iowa Department of Health and Human Services (IHHS). Governor Kim Reynolds appointed Garcia to oversee the state's social services agency in November 2019. She was unanimously confirmed by the Iowa Senate on Feb. 26, 2020. Later that year, Garcia was asked to serve as interim public health Director. As a dual director, Garcia led the agency's pandemic response, while shepherding consolidation to a single health and human services structure. Two years later, Kelly leads Iowa's largest agency, with a commitment to transparency and accountability. The key to this success is building strong teams, transforming the agency's business processes and driving home on a human-centered strategic vision.

Before moving to the Hawkeye state, Garcia led improvements in organizational structure, program management, and policy development in the great state of Texas, including serving in several executive positions at the Texas Health and Human Services Commission. Garcia has more than 20 years of experience in program evaluation and budget, planning and policy development. Garcia is a graduate of The University of Texas at Austin and received her MPA from The Bush School of Government and Public Service at Texas A&M University. She was a member of the Governor's Executive Development Program sponsored by the LBJ School of Public Affairs and has been acknowledged as a distinguished alumnus. She is married to attorney Dan Garcia, and they have two children.

Dr. Hunter has also served as the Co-Director of the Iowa Statewide Perinatal Care Program for the last 19 years, as well as serving on many state and national committees dealing with maternal healthcare. He is also the Principal Investigator of the current 5-year, 10-million-dollar Maternal Healthcare Initiative grant from HRSA. He has also authored several articles, and recently served as Guest Editor for the journal Clinics in Obstetrics and Gynecology, where the topic was maternal healthcare in rural America.

Still his favorite titles remain husband, father and especially grandpa (PaPa). During his free time he enjoys his two hobbies, photography and recreational shooting, especially extreme long-distance shooting.

Heather Rouse is an Associate Professor of Human Development and Family Studies at Iowa State University. She is also founder and Director of Iowa's Integrated Data System for Decision-Making (I2D2). Rouse's training and experience spans three U.S. states, including formal education from the University of Pennsylvania's Graduate School of Education where she received her Ph.D. in School, Community, and Clinical Psychology before serving as a research-policy fellow in Philadelphia's Deputy Mayor's Office. Heather has been actively engaged in early childhood research for over two decades in collaboration with state and local partners, with expertise in areas including early education, child welfare and homelessness, preschool access, Head Start, home visiting, and access to health care.

She teaches courses on child and family policy, early childhood programs and policy, and infant mental health, and also serves on her department's graduate education committee which supports the training and curriculum development of graduate students. The work she and her team have done with I2D2 is recognized nationally as a model in the development and use of integrated data systems to advance strategic planning, including invitations from the National Academy of Sciences, Health Research Services Administration, and the Administration for Children and Families.

Dr. Wells has been practicing "full scope Family Medicine" in Corydon since graduating from Family Medicine residency in 1989. Originally from neighboring Plano, Iowa (population 70), and a graduate of Seymour Community High School, Dr. Wells attended Northeast Missouri State University and received his medical degree from the Kirksville College of Osteopathic Medicine in 1986. He completed his internship at Warren General Hospital, Warren, Ohio, followed by his residency at Barberton Citizens Hospital in Barberton, Ohio. He continues to serve Wayne County and surrounding communities for the last 34 years.

During his career at Wayne County Hospital, he was in private practice for his first 22 years and then as an employed hospital physician the last 13. He has practiced obstetrics as a two-person Family Practice partnership, a three-person group, 12 years solo, a CNMW-Family Practice combo, and now a six person group with five Family Physicians and one CNMW. He has always provided inpatient hospital care, ER care, supervision of mid-level providers, and provided C-section and epidural services. He no longer provides epidural services as of 2020.



PH.D., MPH – UNIVERSITY OF MINNESOTA RURAL HEALTH RESEARCH CENTER



## Nicole Newman


R.D., L.D., CLC- STATE WIC BREASTFEEDING COORDINATOR, IHHS

COORDINATED INTAKE & REFERRAL MANAGER, NINE2THRIVE


