Iowa HHS updated the <u>Maternal Health Strategic</u> <u>Plan in 2023</u> to capture the work being done in the state to address maternal health and continues to use the Strategic Plan to prioritize efforts to improve maternal health outcomes.

Title X Family Planning Program https://opa-fpclinicdb.hhs.gov/

The Title X Family Planning Program is the only Federal program dedicated to providing comprehensive family planning and preventive health services. The family planning clinics offer reproductive health services and community education across the state of Iowa. These services include broad range of family planning methods as well as the HPV vaccination, provision of HIV pre exposure prophylaxis (PrEP), breast and cervical cancer screening, and screening for obesity, smoking, drug and alcohol use, mental health, and intimate partner violence. **Iowa's Healthy Pregnancy Program** (referred to as Maternal Health Programs) https://hhs.iowa.gov/Bureau-of-Family-Health/Maternal-Health/Pregnancy-Resources

Limited Doula Services are currently available through a pilot project in Polk, Black Hawk, Scott and Dubuque Counties. A doula is a trained, non-medical professional who will provide continuous emotional and physical support before, during, and after childbirth.

The Iowa Maternal Quality Care Collaborative (IMQCC) is a multidisciplinary task force that serves as the principal oversight body responsible for improving communication and collaboration among groups addressing obstetrical care in Iowa.

In 2023, the IMQCC will launch a subcommittee for Preconception and Prenatal Care to share resources with providers related to preconception and prenatal care and inform Iowa HHS on strategies to support the Maternal Health Strategic Plan. The subcommittee will also focus on ensuring Family Medicine practitioners who provide prenatal care have resources and support to continue to provide this essential service.

Works to mitigate the effects of sexually transmitted infections among lowans, including through partnerships with other groups, agencies, and organizations for the delivery of information and services. The STI Program has established 58 provider sites for gonorrhea and chlamydia testing and treatment through a network of local health departments and medical providers that work to control these infections.
